City Council Minutes May 9, 2022

The meeting was called to order in the Council meeting room at 7:00 p.m. by Mayor Hegwood. Present were Lance DeLissa, Mitch Brenner (by telephone), Roberto Holguin, Brian Kroth, and George Lucas. Also, present was City Administrator Dean Cordes and City Clerk Janet Gleason. Attorney Clay Kuhns was not present. Visitors were Tom Kuhns, Bobbie Allison, Brad Ackerman, and Jamie Boese.

Brad Ackerman requested a donation for the City Fourth of July fireworks. Motion by Kroth, second by DeLissa to donate \$1,500.00 for the Chamber fireworks display. Motion carried with all in favor.

Boese gave an update on the housing project. WK Construction will begin framing the homes this week. KHRC has been granted an additional \$68 million in funding for housing. They intent to grant \$5 million next year in each of three rounds of grant application periods for moderate income housing. The first will open in June and applications will be due in September.

There was no public comment.

Minutes of the April 25, 2022, meeting were approved as written.

There were no building permits.

Motion by DeLissa, second by Kroth to pay the \$4,872.00 additional EMC insurance premiums that were not in the original quote, for a total EMC insurance premium of \$162,986.00. Motion carried with all in favor.

Motion by Kroth, second by Lucas to approve the Appropriations Ordinance of \$458,024.83. Motion carried with all in favor.

Council directed Cordes to discuss the issue of swimming pools in front yards to the Planning Committee to make recommendations to the council regarding possible regulations.

Cordes informed council there have been fluctuations in the cost of power and predictions of possible shortages and higher rates this summer. He is hopeful the current fuel adjustment will cover the increased cost.

Motion by DeLissa, second by Kroth to approve the 2022 appointments as presented on the list. Motion carried with all in favor.

AN ORDINANCE OF THE CITY OF MEADE, KANSAS ESTABLISHING A RENEWABLE PARALLEL GENERATION POLICY AND ADOPTING BY REFERENCE INTERCONNECTION STANDARDS FOR INSTALLATION AND PARALLEL OPERATION OF CUSTOMER-OWNED RENEWABLE ELECTRIC GENERATION FACILITIES.
