

ORDINANCE NO. 903

AN ORDINANCE AMENDING THE CODE OF THE CITY OF MEADE, KANSAS PROHIBITING THE PARKING OF ANY VEHICLE ON THE CITY OF MEADE, KANSAS TRUCK PARKING LOT WITHOUT PERMIT AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MEADE:

SECTION 1. The Code of the City of Meade is hereby amended by adding a section which reads as follows:

16-2.13 PARKING ON TRUCK PARKING LOT

- 16-2.13.1 **PARKING LOT ESTABLISHED.** The City shall establish and maintain a parking lot for the purposes of allowing semi-trucks and/or semi-trailers to park off of City streets. The parking lot shall be designated for City residents only.
- 16-2.13.2 **PERMIT FEE.** The City shall charge a \$20.00 monthly permit fee for each semi-truck and/or semi-trailer using the parking lot to offset the costs of maintaining the parking lot.
- 16-2.13.3 **PROHIBITED USE.** It shall be unlawful for any person, corporation, partnership, association or business to park any vehicle, semi-truck, and/or semi-trailer on the parking lot without having first paid the monthly permit fee.
- 16-2.13.4 **PENALTY.** A violation of 16-2.13.3 shall be punishable by a fine of up to \$500.00. Each day of violation shall constitute a separate and distinct offense.

SECTION 2. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its summary of publication in the Official City Newspaper.
