

ORDINANCE NO. 920

AN ORDINANCE REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY OF MEADE, KANSAS; INCORPORATING BY REFERENCE THE “UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES,” 38th EDITION, 2022, AND AMENDING ARTICLE 1, OF CHAPTER 12 OF THE CODE OF THE CITY OF MEADE, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MEADE:

SECTION 1. Article 1.1.1 of Chapter 12 of the Code of the City of Meade, Kansas is hereby amended to read as follows:

There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Meade, Kansas, that certain code known as the "Uniform Public Offense Code for Kansas Cities," 38th Edition, 2022, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas, save and except such articles, sections parts or portions are as hereafter, omitted, deleted, modified or changed, in this Article or in the City Code, including the following:

SECTION 2. Article 1.1.1 of Chapter 12 of the Code of the City of Meade, Kansas is hereby amended to read as follows:

No fewer than three copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as Incorporated by City Code Section 12-1.1," with all sections or portions thereof intended to be omitted or changed clearly marked to show any such omission or change and to which shall be attached a copy of this ordinance, and filed with the City clerk to be open to inspection and available to the public at all reasonable hours.

SECTION 3. EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its summary of publication in the Official City Newspaper.
