#### City of Meade

The council meeting was called to order in the council meeting room at 7:00 P.M. by Mayor Richard Knott. Council members present were Roger Musgrove, JD Hegwood, Bart Fischer, Brian Kroth and Lance Delissa. Also, present were City Administrator Dean Cordes, City Attorney Clay Kuhns, City Clerk Janet Gleason. Visitors were Randi Vanderpool, Michael Inlow, Leslye Flaherty, Rhonda Johnson and Tom Kuhns.

First on the agenda six utility extension agreements were granted.

Chief Inlow presented the police report and requested the 15-month increase for Officer Wondra. Musgrove motioned to grant Officer Wondra a 15-month increase, Hegwood seconded. Motion carried. Inlow then presented Mather's animal control report. Musgrove opened discussion regarding the hiring of an addition police officer for the city. Inlow presented information regarding officer hours and pay. Fischer asked Inlow if he could make a 4<sup>th</sup> officer work with the current equipment and Inlow stated that current equipment is in good shape but would need upgrades. Cordes asked if hiring another officer would do away with the use of reserve officers. Inlow stated it would reduce it but not eliminate it. Delissa suggested that realistic costs need to be determined prior to the next budget year because an officer cannot be added until then. He also feels the decision of adding an officer should be up to the community to decide with information regarding what the cost to the taxpayers would be. Fischer requested Inlow bring more information on the financial costs of an additional officer to the next council meeting. Mayor Knott stated that an officer cannot be added until the next budget year so it will be important to break out all costs involved and present them to the auditors when the budget planning begins for the next year. Cordes mentioned that the Sheriff's office had indicated at one time that the dispatch costs to the city would increase if the city added another officer and that it would be important to find out how much those costs would increase.

January 14, 2019 minutes were approved as written.

Building permits #19004 and 19005 were approved on motion made by Fischer, seconded by Kroth with all in favor.

Resolution 302 was approved on motion made by Fischer, seconded by Musgrove with all in favor.

Delissa motioned for Hegwood and Kroth to represent the City on the Board of Directors of KMEA, Musgrove seconded. Motion carried with all in favor. Cordes presented a thank-you for the donation for the Crooked Creek classic that was signed by the participants.

Gleason presented the Treasurer Reports and revised utility application and extension forms. Council gave consent for Gleason to attend the Spring City Clerks Conference. Hegwood motioned to renew the contract for administration of the HRA plan to TASC. Seconded by Delissa. Motion carried.
